1. **ELIGIBILITY:** The online social media sweepstakes promotion (the "Sweepstakes") is open to legal residents of the United States who are at least 18 years of age. Completing and submitting the online sweepstakes entry form is the only means of participating in the Promotion. One entry per email address per calendar day allowed. All email addresses will be added to the Houston Livestock Show and Rodeo Email Database, which has an opt-out option.

Entrants will be entered into the Sweepstakes upon completion of the online entry form. Persons who enter the Sweepstakes under false contact information, as determined by the Administrator will be disqualified and ineligible to win the sweepstakes. All information provided by entrant must be complete, true and correct. Submissions to the Sweepstakes must be received by 11:59:59 pm CST on Sunday, Jan. 4, 2026 in order to be eligible; entries received after that date will be deemed ineligible to win. Entrants agree to be bound by

these Official Rules. Administrator reserves the right to cancel and re-schedule the Sweepstakes at any time if the technical transmissions become corrupted or interrupted.

5. **PRIZES:** One winner will be awarded access to an all-inclusive suite for eighteen (18) guests for one performance in NRG Stadium during the 2026 Houston Livestock Show and Rodeo. An all-inclusive suite includes food, beverage and alcohol pre-determined by Administrator. The date of the performance will be determined by the Administrator. The winner will be asked to submit their top five choices for the performance date but the final performance date selection will be up to the sole discretion of the Administrator.
